## 2019 Rebate Conditions

The Community Office of Resource Efficiency (CORE) offers cash-back rebate incentives for households in the Roaring Fork Valley (Aspen to Glenwood Springs). This includes all Glenwood Springs Electric customers. Homes in Glenwood Springs, not on the Glenwood Springs Electric Grid or in the Roaring Fork Valley, are not eligible for CORE rebates. The following information is required for your rebate application

- Invoice or receipt showing proof of payment
- Signed [W-9](#)
- Signed utility waiver
- Photograph of the upgrade

Please allow for three to four weeks for processing.

A [1099-Miscellaneous Income](#) form will be sent to customers at the end of the calendar year. Rebates may be subject to income tax.

### **Rebate Conditions:**

- Projects are subject to applicable existing regulations and permit requirements. Please consult with your local building department for more information on permit requirements.
- Applications must be submitted within six months of project completion or of final invoice date. Funds are awarded on a first-come, first-served basis.
- Some rebates may require a Home Energy Assessment be performed.
- Households are eligible for one rebate per project type every five years.
- CORE reserves the right to change rebates, standards or availability without notice.
- The total rebate shall not exceed 50 percent of project costs when combined with other rebates.
- Rebates for renewable energy system may be applied to new and existing construction. Energy efficiency rebates are for renovations and retrofits of existing equipment. For a home to be considered new construction for a renewable energy rebate it must be built within the last year, otherwise the home must receive a Home Energy Assessment.
- Do-it-yourself (DIY) projects are eligible for rebates for material costs only.
- To qualify, the house must be located in CORE's geographic territory: the Roaring Fork Valley and Crystal River Valley. This covers Aspen through Glenwood Springs (serving all Glenwood Springs electric customers) and Carbondale through Marble. This territory covers the following zip codes, with a few exceptions: 81611, 81612, 81615, 81654, 81656, 81621, 81623, 81601 and 81602.
- Rebates are not available for systems installed to offset all or part of a building-code mandated installation, i.e. Renewable Energy Mitigation Program (REMP). However, solar PV systems that are two kilowatts larger than what is required by REMF are eligible for the PV rebate.
- CORE reserves the right to inspect the upgrade and promote it through its various media channels.
- CORE retains the right to use all photographs in all forms of advertising and marketing materials. Homeowners retain the right to revoke permission at any time.
